

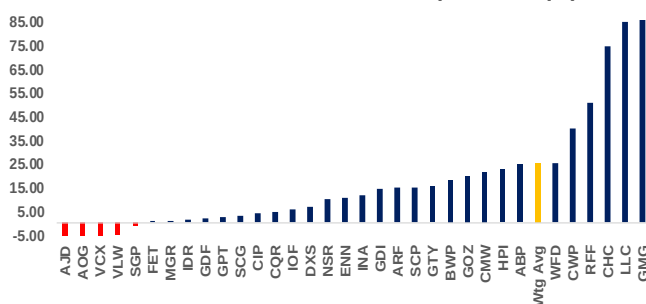

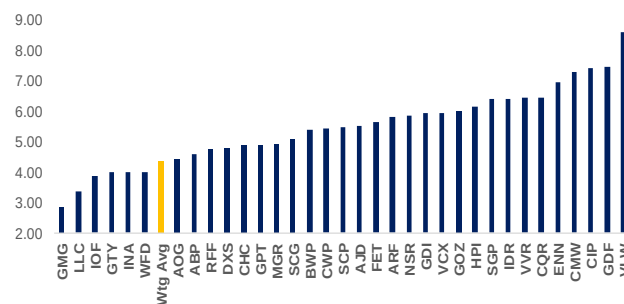

Gross Dividend Yield (%)



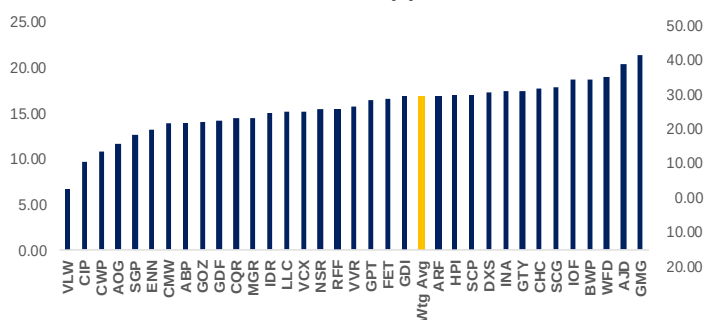

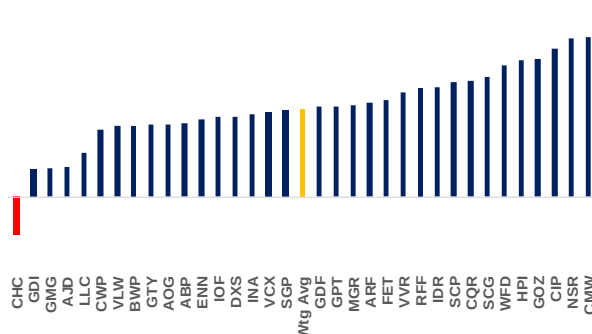
